## CONTENT SUBMISSION AGREEMENT

This agreement is entered into on \_\_\_\_\_, 2001 by and between DSP Films, Inc. (hereinafter Receiver) and \_\_\_\_\_ (hereinafter Submitter). The parties intend to be legally bound and agree as follows.

### 1.01 Background

Receiver is in the business of worldwide distribution of Content over the Internet and any similar networks and mediums involving computers and communication.

Submitter is involved in the creation, authoring and producing of Content it wishes to display with the Receiver.

### 2.01 Definitions

(a) Content shall mean all text, pictures, sound, graphics, animation, video and any other digitized data and information capabilities. It shall also include Submitter's biographical page, film/video pages and film videos.

(b) Site shall mean Receiver's infrastructure composed of servers, browsers, routers, protocols, technologies, applications, networks, transport layers, software, hardware and the like which enable Receiver to upload, download, transmit, display, reproduce, duplicate, distribute and perform Submitter's Content.

### Intellectual Property Rights

Intellectual Property Rights means any rights associated with works of authorship produced anywhere in the world, including but not limited to copyright, trade secrets, patents, moral rights, trademarks, servicemarks and the like. It shall also include rights derived from contracts, transfers, assignments, licenses, operation of law or otherwise.

### Violation of Rights

Violation of Rights means any violation of any worldwide statute, contract, law, regulations, rules, enactment, common law generally and especially involving libel, slander, invasion of privacy, any right of publicity, pornography and the like.

### 3.01 Grant of Rights

Submitter hereby grants to Receiver, worldwide rights to upload, download, transmit, display, reproduce, and duplicate Submitter's Content until Submitter notifies Receiver 7 days prior in writing of revocation of such rights. Further, Receiver shall be permitted to market, sell, advertise, publicize its Site for its individual and sole gain. Lastly, Receiver has the absolute discretion to remove Submitter's Content for violation of any of its Guidelines.

### 4.01 Fees

Receiver reserves the unconditional right to charge Submitter for its services as defined in § 3.01. Upon implementation of such fees, Submitter has the right to cancel this agreement and all of Receiver's rights herein.

### 5.01 Warranty

Submitter represents and warrants that it owns all Intellectual Property Rights to the Content. Further, that this Content as submitted does not Violate Anyone's Rights.
